The late Dr. Aristides de Sousa Mendes do Amaral e Abranches, (July 19, 1885 - April 3, 1954) was the Portuguese Consul First Class in Bordeaux between 1938-1940 when the German armies were Thousands of refugees converged on Bordeaux, conquering Europe. in the southwest of France, hoping to receive a visa from the Portuguese Consul there. Dr. Sousa Mendes was never again permitted to work in the diplomatic service, and died penniless and disgraced in Lisbon in 1954. Since that time, his children have written to political leaders, newspaper columnists and others in their efforts to have their father's story told. His son Sebastian Mendes wrote a book and several articles; daughter Joana assembled the required data that enabled Yad Vashem, the Martyrs and Heroes Remembrance Authority in Jerusalem to award a commemorative medallion posthumously to their father in 1967; trees were also planted, one of them in the Garden of the Righteous in Jerusalem, located on the grounds of the Yad Vashem Museum.

In the spring of 1986 a son, John Paul Abranches, circulated a petition to President Mario Soares of Portugal, that attracted a great deal of attention (see last page). United Congressman George Miller (D-Martinez, CA) and Robert Jacobvitz of the Jewish Community Relations Council of the Greater East Bay, located in Oakland, California, at John Paul's request, contacted Representative Tony Coelho, (D-Merced, CA) the only Congressman of Portuguese ancestry. Under his leadership the United States House of Representatives Resolution 469 was drafted signed by more than 70 colleagues. United Consgressman Henry Waxman (D-Los Angeles, CA) wrote a letter to President Mario Soares, also co-signed by over 70 Congressmen. In September 1986, during a visit to Washington, D.C., Portuguese Foreign Minister Pedro Bires de Miranda announced that President Mario Soares would, at a still unknown date, award a special medal of honor to their father.

In May of 1986, The International Committee for the Commemoration of Dr. Aristides de Sousa Mendes was formed with offices in

Oakland, Californaia and Jerusalem, Israel. The goal of The International Committee is to ensure that the memory of Aristides de Sousa Mendes is appropriately recognized by the world for the lifesaving and ultruistic deed he performed as The International Committee's Consul First Class in Bordeaux. goal is to work with the Portuguese people and government so that history will be properly and accurately recorded. It plans to develop educational material to be used throughout the world; to be used in educating school children as well as adults of Dr. Sousa Mendes' humanitarian actions. The International Committee's aim is to encourage and promote acts of compassion and concern for one another.

The Portuguese government allowed some refugees to remain within its borders for the remainder of the war. Portugal was acclaimed for her humanitarian act on behalf of the refugees, while the man responsible was fired, to die in poverty, forgotten by his homeland.

The government of Israel in 1967 paid homage with a medal inscribed with the Talmudic dictum, "One who saves a human life saves as it were a whole world". The same homage was paid to Racul Wallenberg of Sweden for similar reasons. Thank you for your kind condolences over the death of my brother Philip. He was a good, kind hearted man and we will miss him very much. My only consolation is that he could see that at last our efforts to restore our father's honor were beginning to bear fruit, and he had an active part in it.

Last year you were kind enough to send us a copy of a biography of Dr. Sousa Mendes that you had prepared for Larry Katz of New Bedford as background information for the Holocaust Memorial service in which my father was honored. I finally had the opportunity to read it more closely and wish to make a few corrections.

My father never received any support from any high government officials and especially not from the Cardinal of Lisbon! He did ask for their help, but they refused, and the Cardinal suggested that my father and mother should pray to Our Lady of Fatima! My father did not make a personal appearance before the National Assembly to defend his actions. His "Reclamacao" was typed up and personally distributed to each member of the National Assembly at his home be several of the children, including myself.

I have enclosed an updated copy of a biography I prepared for the B'nai B'rith Women of Canada, who honored my father in a ceremony at the Holocaust Center of Montreal on February 8, 1988. The resources for this biography come from the Portuguese Encyclopedia, yourself, and my recollections.

To the best of my knowledge, my father never worked for HIAS or any other Jewish agency, although the Jewish community was very helpful to us, as I believed I have mentioned in a previous letter. My father tutored two American Attaches around 1944 for a few months.

It is our understanding that Jaime Gama will be introducing a "proposta de lei" for a debate regarding my father before the National Assembly on March 18, 1988. Rui Afonso will be acting as his expert. Several of my nephews will also be present. On April 4, 1988, honorary Israeli citizenship will be conferred post-family members in Lisbon. We have also been told that President Soares and his wife have organized a national commission to honor Dr. Aristides de Sousa Mendes in a non-partisan way. The Jewish community is involved in this commission. A commission has also been formed in Cabanas and members of this group come from the neighboring communities as well. It is unfortunate that my family only learned of this through Rui Afonso, and not from anyone on these committees. The aim of this commission, according to Rui, is to transform the house in Cabanas into a museum and/or center for promoting the humanitarian values of Aristides de Sousa Mendes, and in so doing, stir up enough public interest through the media to pressure the Government/Foreign Office into rehabilitating and/or way things are developing. In Portugal, I believe it will be the grandsons of Dr. Sousa Mendes who will carry on the fight. My older brothers and sisters are too ill, tired and discouraged to maintain a sustained battle with the beaurocracy at this stage in their lives.

We were very pleased to hear about your lecture at Harvard scheduled for April 21, 1988. I am not sure if I will be able to make it myself, but I will inform other family members and friends, and if their schedules permit, I am sure they would be happy to attend.

BRIEF BIOGRAPHY OF DR. ARISTIDES DE SOUSA MENDES (1885-1954)

Dr. Aristides de Sousa Mendes was born in Portugal on July 19, 1885, along with his twin brother, Cesar, to Jose and Angelina de Sousa Mendes do Amaral e Abranches. He graduated from the University of Coimbra, one of Europe's most ancient universities, with a degree in law. He married his cousin, Angelina de Sousa Mendes, and together they had 14 children, one dying in childhood.

Through a competitive examination, he was appointed Consul Second Class on May 12, 1910 and proceeded to his post in Demerara. The following year (July 19, 1911) he went on to serve in Galicia and seven days later he was promoted to Consul General in Zanzibar; Consul in Curitiba on November 13, 1918; First Class Consul on June 20, 1918, went into inactive status on June 27, 1919. Two years later he was ordered to be interim manager of the Consulate in San Francisco (June 11, 1922); he syndicated for the Consulate in Boston (June 22, 1922); then he managed the Consulate in Maranhao (April 2, 1924). Temporarily he was Consul in Porto Alegre (November 14, 1924). He then was transferred to the General Board of Directors of Commercial and Trade Transactions (January 29, 1926), then he was appointed Consul in Vigo (November 29, 1927); Consul General in Genoa (May 2, 1929, did not assume this post) and Consul General in Antwerp (September 7, 1929).

He was decorated with the Red Star of Merit of Portugal, and the Second Class of the Bright Star of Zanzibar and the Official Order of Leopold I of Belgium.

At this point his official biography in the Portuguese Encyclopedia ends, as if he dropped out of sight. However, he was named Consul-General in Bordeaux on August 1, 1938; he served in that post until July 1940, following the fall of France and the advance of German armies to the Pyrenees and the English Channel. Defying the orders of his Foreign Ministry in a heroic effort and action, he along with his staff and two of his sons, signed transit visas for thousands of refugees, including Jews, who sought refuge in Portugal or Spain from the Nazi armies. The Lisbon government, following the orders of Antonio de Oliveira Salazar (1889-1970), Premier and Foreign Minister at the time, suspended Sousa Mendes from the Foreign Service on July 27, 1940. The following March 21, 1942, according to official records, Dr. Sousa Mendes was placed in the status of "awaiting retirement", a position he held until his death in Lisbon on April 3, 1954. For the record, his name, despite the fact that his official fate had not been decided until 1945, in effect, disappears from the list of Consul-Generals he was a part of for many years, in the Annual Diplomatic and Consular List beginning in 1944. There was no response from the government, despite a Claim he wrote in his own defense and hand delivered by his sons to each member of the National Assembly in September 1945, following the end of World War II.

Sousa Mendes Biography Page Two

After his death, Dr. Sousa Mendes' children continued in their efforts to clear their father's name. On October 9, 1967, a commemorative medallion honoring their father was presented to a daughter, Joana, by the Consul General of Israel in New York. A tree bearing his name was planted along the Avenue of the Righteous, located on the grounds of Yad Vashem, the Holocaust Remembrance Authority in Jerusalem. On May 19, 1986, in Washington D.C., President Soares of Portugal presented the "Ordem de Liberdade" medal to Joana in recognition of her late father's heroic deeds. Both of these presentations were made in the presence of other family members and friends. Through the efforts of the late Dr. Sousa Mendes' children, members of the community, and government representatives in the United States, Canada and Israel, various resolutions and citations were awarded in recognition of his heroic acts.

Still, in 1988, the government of Portugal has not officially recognized its hero. The International Committee for the Commemoration of Aristides de Sousa Mendes, formed in the Spring of 1986, continues in its efforts to make the story of this brave diplomat known throughout the world, and honored in his homeland.

Dear Mariana:

I hope you and your family are well. We are fine after a very unhealthy winter. We hear from Francisco from time to time and he keeps us up to date with your very heavy schedule and your travels.

I am enclosing some correspondence to bring you up to date with what has been happening with us. As you know, Philip Mendes died this past January in Montreal, and we all miss him. He has had kidney problems for a while but this past year his condition had worsened more than we realized. We know that he was delighted that the world was beginning to become aware of his father's heroic actions, and his memory was in the hands of those who would treat it with respect. Also enclosed is a copy of our response to the Portuguese American Congress for their contribution, not only to the International Committee but especially to the Portuguese American Scholarship Foundation.
